# REVISED SYLLABUS FOR M.Sc. PROGRAMME IN ANTHROPOLOGY UNDER CHOICE BASED CREDIT SYSTEM (CBCS), (FROM THE SESSION 2017 – 2018 ONWARDS)

#### PROGRAMME STRUCTURE

The M.Sc. Programme in Anthropology under CBCS is divided into two parts and each part comprises of two semesters (two odd semesters and two even semesters). Each semester is made up of 16 Credits (400 marks). So the total credits of the course are 16x4= 64 (marks=1600). Semesters I and II have core compulsory papers to be studied by all students who are admitted to the M.Sc. Anthropology programme. The first part of Semester III is made up of compulsory courses to be studied by all the students of this semester while the second part of Semester III is arranged in two groups which are made up of core with elective courses to be taken from specific group. Semester IV is composed of core and elective courses arranged in two groups. The papers include both theoretical and practical papers. Field studies in all the three sub-disciplines are compulsory. The internal evaluation consists of class tests, comprehensive viva, term papers, group discussions, seminars and book reviews.

At present the Department is offering core papers in Physical Anthropology, Prehistoric Archaeology and Social Cultural Anthropology while elective papers are being offered only in Social Cultural Anthropology and Physical Anthropology.
